An argument from authority, also called an appeal to authority, or argumentum ad verecundiam, is a form of argument in which the opinion of an authority on a topic is used as evidence to support an argument. Some consider that it is used in a cogent form if all sides of a discussion agree on the reliability of the authority in the given context. Other authors however consider it to always be a fallacy to cite an authority on the discussed topic as the primary means of supporting an argument.

Under U.S. law, 28 U.S. Code (U.S.C.) § 1782, foreign judicial authorities or parties to proceedings can request the assistance of U.S. courts in taking evidence for use in a proceeding in a foreign or international tribunal without filing a request under the Hague Evidence Convention. Evidence may be obtained from both parties and non-parties to the foreign litigation.
